## टिल्लू ताजपुरिया गैंग क शूटर चढ़ा हत्ये

नई दिल्ली। काइम बांच ने टिल्लू ताजपुरिया गैंग के शार्प शूटर सोनू धनकड़ उर्फ दिनेश उर्फ धिवकी (23) को गिरफ्तार किया है। इसके पास से एक पिस्टल और दो कारतूस बरामद किये गये हैं। पुलिस के अनुसार आरोपी शूटर हत्या के प्रयास और लूट की वरदात में शामिल रहा है। इसके अलावा पुलिस ने पता चला कि शूटर गिरोह के अन्य सदस्यों के साथ मिलकर दिनेश गैंग के बकवारा को हत्या करने के फिराक में थे। हेडकांस्टेबल अजय को 12 नवंबर को सूचना मिली कि सोनू पीतमपुरा इलाके में आने वाला है। पुलिस ने पीतमपुरा मेट्रो स्टेशन के पास एक ट्रैक लगाया और रोहतक निवासी सोनू को दबोच लिया। सोनू गिरोह संगठन टिल्लू के दिशा-निर्देशों पर संगठन को वसूलने का काम भी करता था। विजय किर्मा और गौरव रोहिणी के दो मामलों में वह वाटेड रहा। विजय विहार में इसने अपने साथियों के साथ निरुकेबल ऑपरेटर के रोहिणी सेक्टर-5 ऑफिस पर फायरिंग की थी। केबल व्यवसायी से ये लोग तो प्रोटेक्शन मनी की डिमांड कर रहे थे। वहीं रोहिणी केस में इसने गन प्वाइंट पर स्फूटी लूटी थी। इसी अलावा आरोपी शूटर केएन काटजू मार्ग व शहीद डेयरी थाबा प्रिया के दो हत्या के प्रयास मामलों शामिल रहा है। इसमें इसका साथ खुद सुनील उ टिल्लू उमेश और चंदन में दिया था।
